COURSE DESCRIPTION: Introduction to the entire discipline of forestry, including the history of forest use and management, North American forest regions, forest ecology, mensuration and management, forest products and the importance of forest resources other than wood fiber. Also provides an overview of state, regional and local employment opportunities in the field of natural resource management.

WRITING ASSIGNMENTS:

Article Reviews

The student will complete eight article reviews by summarizing the important points of a given article. The purpose of an article review is to acquaint the student with journal and magazines that deal with Forestry and related areas. Rather than assign specific articles, students will write eight (8) reviews from eight different journals. Reviews should be 250-300 words. Write the review in your own words not that of the article author. The review should cover a summary of the primary points of the article as well as what the student thinks about the article.

Using the above Journals students will write on research paper on a subject of their choosing, using the guidelines from below.

Purpose: Forest management, like other applied sciences, requires updates from current research and practice. It is important for students to know about these sources and how to access and use them.

Format: Title page (abstract # & title, name, class, due date)
Typed Double spaced, 12 pt. Font; no handwritten papers accepted.
Summary of your research, 250-300 words
Bibliography (listing of reference(s))

Concept: Identify a forestry related topic or issue of your choice, which involves differing viewpoints. From relevant information sources describe what you have learned about the issue, noting several opinions, and summarize with your own opinion.

Requirements: At least one citing must be from a forestry related journal listed above. All citations may be from on-line information or hard copy journals.

Sources: Resource journals, on-line or hardcopy. Use the COCC Library website. Internet search engines will locate a large variety of other sources and information. Consider carefully the source of this information as it is usually not peer reviewed as are most professional journals.

Lab / Field Trip Reports

Lab reports will be required for a minimum of five labs. The reports will be typed, double-spaced and 1-2 pages in length. The reports should include the objective of the lab, the location, the high points of the lab and include the student's thoughts relative to the lab. **Reports will be due one week from the day of the lab/field trip.**

C OCC Blackboard will be used for course management and posting of content. All students will be issued a COCC Student ID # which will allow access to the COCC Barber Library on-line journals to assist in article review assignments.

Instructional Methods: The course will be taught using a variety of methods including: lecture, class discussions, video presentations, guest lectures, field tours, and written assignments.

Instructional Outcomes:

- 1. The student will be able to describe past and present uses of the forest.**
- 2. The student will be able to distinguish between conservation, preservation, and environmentalism.**
- 3. The student will be able to describe forest regions of the United States.**
- 4. The student will be able to compare and contrast the influences of Gifford Pinchot & John Muir.**
- 5. The student will be able to describe Forest Service organization.**
- 6. The student will be able to describe the Oregon Dept. of Forestry organization.**
- 7. The student will be able to read and prepare abstracts from resource management journals.**
- 8. The student will be able to list examples of the work of a forester.**
- 9. The student will be able to describe various forest resources and their management issues.**
- 10. The student will be able to use vocabulary related to forest management and practice.**

Plagerism Statement: All students are expected to practice the highest standards of academic honesty.
